Pajaro Valley Storm Drain Maintenance District (PSDMD).
Flood Control District - Zone 7 encompasses the Pajaro River and
Salsipuedes Creek levee systems. Routine work performed by the Crew
consists of slope compaction, slope and bench mowing, rodent control,
flap gate inspections, culvert maintenance, levee road repairs and

channel vegetation clearing. Each fall as winter approaches, the Drainage Crew shifts their focus to vehicular inspections (winter patrol) of the levees and flood fighting preparation. On occasion the Pajaro River mouth closes causing localized flooding at the Pajaro Dunes development and West Beach Road. During these events the Crew will respond with a skilled operator and excavator to breach the river mouth. The breaching work is done with the guidance of County Flood Control staff, permitting agency staff and local biologists. A successful breach results in the river mouth staying open throughout the remainder of the rainy season.

The work the Crew performs in Zone 7 and PSDMD is often visible to the public and high profile, however, the work done in other Flood Control Districts throughout the County is often unseen, but, nevertheless just as important in protecting our communities. The Crew continuously performs work in the County's drainage channels, sometimes involving hand work, to clear vegetation, downed trees, unclogging culverts, replacing culverts, removing built up debris and clearing debris racks. During the rainy season the Crew focuses its efforts on continuously inspecting drainage channels and flood fighting. In the rainy seasons following the CZU Lightning Complex Fire the Drainage Crew responded to multiple North County channel crossings along County roads to clear burnt debris for the safety of County residents and the motoring public. This work is especially important to mitigate the increased risk of hazardous debris flows in the burn zone.



SCCSD MANHOLE INSPECTIONS

he Santa Cruz County Sanitation District (SCCSD) has approximately 4,780 concrete manholes of varying ages, which range from a couple of feet in depth to over twenty feet. Hydrogen Sulfide (H₂S) gas is common in sewer systems and deteriorates concrete over time. Sanitation Operations staff have recently embarked on an inspection program to evaluate each manhole.

In order to get organized for the inspection program, Sanitation Operations staff worked with Public Works' GIS Analyst, Bryan Kriete, to create a manhole assessment form in Lucity (our Asset Management Software) which allows operation staff to inspect and identify deficiencies with the use of a tablet, and track which manholes have been inspected. The manhole assessment information is used by Sanitation Engineers so that rehabilitation of the manholes can be prioritized and a budget can be developed.

Over the years, the Sanitation group has experimented with various treatments to fix deteriorated manholes and has had success with epoxy lining. See attached photos showing a deteriorated manhole and the lining process. The cost for the epoxy lining varies with manhole depth and quantity of manholes to be lined, but on average, the cost to line a manhole is around \$5,000. Additionally, when manholes are lined, typically new frames and covers are replaced that are made from composites which will be more resistant to corrosion and will be easier for operations crews to lift. Many thanks to those involved in the manhole inspection program and their dedication to improving the sewer system for residents!









GROUNDBREAKING ON 57 AFFORDABLE APARTMENTS

fter five years of planning and effort by multiple County departments, including Economic Development, Housing, Development Review, Building, multiple DPW divisions, Environmental Health, Health Services Agency, and various outside agency partners, on March 16, 2022, building permits were issued for construction of 57 affordable apartments for families and at-risk tenants at 1520 Capitola Rd. in Live Oak. Construction will begin on March 21st.



These apartments are the second phase of construction on a mixed-use development (MLD 18-1579) on former RDA property. The first phase included two new non-profit health clinics (Dientes Dental and Santa Cruz Community Health Center), currently under construction in front of the housing site. The apartments are scheduled to be completed by August 2023. The project includes 10 units for extremely low-income households, 28 for very low income households, and the balance for low-income households. It is the first major 100% affordable rental project to break ground in the unincorporated area since late 2016. It will contribute significantly toward the County's regional housing needs allocation (RHNA) objectives for the 2015-2023 RHNA period. The project re-



ceived a wide range of funding including a loan of Low-Mod **Housing Funds** from the Housing Division, a NPLH loan from **Health Services** Agency, an award of project -based vouchers from the Housing Authority, and 2020 Disaster Tax Credits through the State of California Tax Credit Allocation Committee (CTCAC).


